COMMONWEALTH OF AUSTRALIA
ADMINISTRATIVE ARRANGEMENTS ORDERED BY
HIS EXCELLENCY THE GOVERNOR-GENERAL

I, SIR ZELMAN COWEN, the Governor-General of the Commonwealth of Australia, acting with the advice of the Federal Executive Council—

- (a) hereby revoke so much of the Administrative Arrangements Order made on 28 September 1978 as relates to the Department of Construction, the Department of Employment and Industrial Relations, the Department of Environment, Housing and Community Development and the Department of Science; and
- (b) hereby approve the following administrative arrangements:
- (i) the matters dealt with by a Department of State specified in the first column of the Schedule include the matters specified in the second column of the Schedule opposite to the name of the Department and other matters arising under the enactments administered by the Minister of State administering that Department;
 - (ii) the enactments administered by the Minister of State administering a Department of State specified in the first column of the Schedule are the enactments specified in the third column of the Schedule opposite to the name of that Department and any other enactments, whether passed on or after the date of this Order, that relate to a matter dealt with by that Department (not being an enactment specified in relation to another Department in the Administrative Arrangements Order made on 28 September 1978 as affected by this Order);
 - (iii) the matters dealt with by the Department of Administrative Services include—
 Provision of Commonwealth hostel accommodation
 Migrant accommodation;
 - (iv) the matters dealt with by the Department of Home Affairs include—
 Leisure, including sport, physical fitness and community recreation;
 - (v) the enactments administered by the Minister of State for Home Affairs include the *Australian Heritage Commission Act 1975* and the *National Fitness Act 1941*, and the matters dealt with by the Department of Home Affairs include matters arising under those Acts;
 - (vi) the matters dealt with by the Department of National Development include—
 Decentralization and urban planning and development
 Local government;
 - (vii) the enactments administered by the Minister of State for National Development include the *Cities Commission (Repeal) Act 1975*, the *Land Commissions (Financial Assistance) Act 1973*, the *Sewerage Agreements Acts* and the *Urban and Regional Development (Financial Assistance) Act 1974*, and the matters dealt with by the Department of National Development include matters arising under those Acts; and
 - (viii) the enactments administered by the Minister of State for Trade and Resources include sections 41A, 41B and 41C of the *Atomic Energy Act 1953*, and the matters dealt with by the Department of Trade and Resources include matters arising under those sections.
