## **SFIA**

- An open source, two dimensional skills matrix developed in 2003 (v.1) by the SFIA Foundation, a UK consortium comprising IET, IMIS e-skills UK, and BCS (V.7 currently in use)
- A capabilities framework which can be used globally
- A tool for aligning a workforce to deliver the needs of an organisation

## Why new PS Scheme is a big deal:

- Society needs identifiable experts (professional & ethical)

## **How PS Scheme works**

- Association monitors, enforces & improves member practices
- Consumer risk is reduced
- Professional Standards Councils cap civil liability
- Benefits CP members; guards against insurance crisis
