

APPOINTMENT OF A WHARF IN THE PORT OF
BRISBANE, QUEENSLAND.

PROCLAMATION.

Commonwealth of
Australia to wit:
GOWRIE
Governor-General.

By His Excellency the Governor-
General in and over the Com-
monwealth of Australia.

WHEREAS by Section fifteen of the *Customs Act 1901-1936* it is enacted that the Governor-General may, by Proclamation, appoint wharfs within ports and fix their limits;

And whereas it is desirable to appoint a wharf within the port of Brisbane in the State of Queensland and to fix the limits of such wharf;

Now therefore, I, Alexander Gore Arkwright, Baron Gowrie, the Governor-General aforesaid, acting with the advice of the Federal Executive Council, do hereby appoint the following wharf in the port of Brisbane, State of Queensland, to be a wharf within the meaning of the said Act and fix the limits of such wharf to be as follows:—

NEWSTEAD WHARF, PORT OF BRISBANE.

All those wharf premises commencing on the southern boundary of Newstead Park at the north-western corner of Sub. 6 of Resub. 47 of Sub. 70 of E.S.A. 63 Parish of North Brisbane and bounded thence on the north by part of that Park and by lines bearing 99° 26' for 320 links and 3/10 of a link, 80° 11' for 68 links and 94/100 links 109° 34' for 13 links and 13/100 links, on the north west and north east by lines bearing 18° 15' for 1 chain 64 links, 108° 15' for 1 chain 51 links and 53/100 of a link, on the east by the quay line of the Brisbane River by lines bearing 198° 9' 40" for 4 chains 92 links and 85/100 of a link, 191° 18' 30" for 71 links and 64/100 of a link, 183° 4' for 8 chains 36 links and 58/100 of a link 173° 48' for 68 links and 34/100 of a link, 163° 10' 40" for 7 chains 26 links and 4/100 of a link, on the south, west and south by lines and part of the northern boundary of Sub. 158 of E.S.A. 62, bearing 253° 10' 30" for 93 links and 76/100 of a link, 343° 10' 30" for 79 links and 92/100 of a link 253° 10' 30" for 1 chain 79 links and 3/100 of a link, 260° 59' 22" for 61 links and 26/100 of a link, on the west, south and south-east by lines bearing 336° 42' for 65 links and 1/10 of a link, 57° 21' for 42 links and 97/100 of a link 342° 56' for 2 chains 22 links and 34/100 of a link, 336° 2' for 1 chain 57 links and 28/100 of a link 261° 10' for 1 chain 4 links and 16/100 of a link, 217° 6' for 40 links and 79/100 of a link, 221° 6' for 75 links and 2/10 of a link on the west by Newstead Terrace bearing 350° 59' 22" for 1 chain 24 links, on the north, west and south, by lines bearing 80° 59' 22" for 96 links and 61/100 of a link, 7° 18' for 1 chain 79 links and 65/100 of a link, 350° 4' 1-chain 85 links and 76/100 of a link, 261° 3' for 1 chain 46 links and 13/100 of a link, again on the west by Newstead Terrace bearing 350° 59' 22" for 2 chains 89 links and 76/100 of a link, 9° 26' for 2 links and 97/100 of a link on the north, west and south by lines bearing 91° 13' for 1 chain 33 links and 24/100 of a link, 79° 55' for 49 links and 92/100 of a link 7° 56' for 3 chains 37 links, 1° 30' for 1 chain 49 links and 46/100 of a link, 277° 53' for 1 chain 49 links and 4/10 of a link, again on the west by Newstead Terrace bearing 9° 26' for 50 links, on the north, west and south by lines bearing 97° 53' for 1 chain 48 links and 52/100 of a link, 19° 8' for 3 chains 41 links and 2/100 of a link, 339° 28' for 48 links and 59/100 of a link, 279° 26' for 1 chain 81 links and 57/100 of a link, again on the west by Newstead Terrace bearing 9° 26' for 50 links and 86/100 of a link to the point of commencement

HOBART, TASMANIA.

PROCLAMATION

By His Excellency the Governor-
General in and over the Common-
wealth of Australia.

WHEREAS by section fifteen of the *Customs Act 1901-1936* it is enacted that the Governor-General may, by Proclamation, appoint wharfs within ports and fix their limits;

And whereas it is desirable to appoint and fix the limits of a wharf at Port Macquarie, Hobart, State of Tasmania;

Now therefore I, Alexander Gore Arkwright, Baron Gowrie, the Governor-General aforesaid, acting with the advice of the Federal Executive Council, do hereby appoint the following Wharf at Port Macquarie, in the port of Hobart, State of Tasmania, to be a Wharf within the meaning of the said Act and fix the limits of such Wharf to be as follows:—

OIL WHARF, PORT MACQUARIE, HOBART.

That wharf situate in the port of Hobart known as the Oil Wharf, containing an area of one rood thirty perches. Commencing at the change of alignment on the Eastern side of Murdoch-street and bounded as follows:—On the West by a straight line bearing North-Westerly for a distance of 164 ft. 4 in., thence on the North by a straight line bearing South-Easterly for a distance of 73 ft. 10 in. along the Northern face of the wharf. Thence on the East by a straight line bearing South-Westerly for a distance of 323 ft. along the Eastern face of the said wharf. Thence on the South by a straight line bearing North-Westerly for a distance of 80 ft. 9 in. along the Southern side of the said wharf. Thence again on the West by a straight line bearing North-Easterly for a distance of 163 ft. 5 in. along the Eastern side of Murdoch-street and extending to the point of commencement.

This Proclamation may be cited as Customs Proclamation No. 426. (T. & C. '39/6816.)
