THEREAS by the Air Force Regulations it is prescribed, inter alia

- (a) that the Governor-General may by order declare any area to be an air fighting, gunnery, bombing or similar practice area;
- (b) that a ship, boat, aircraft or person shall not come or remain within any area so declared while any air fighting, gunnery, bombing or similar practice, as the case may be, is in progress, or remain in any position so as to obstruct such practice:

Now therefore I, William John McKell, the Governor-General aforesaid, acting with the advice of the Federal Executive Council, do hereby declare the area described in the Schedule hereto to be an air to air firing area.

THE SCHEDULE.

New South Wales.

All that area of sea being part of the South Pacific Ocean bounded by a line commencing at a point situated in latitude 29 degrees 18 minutes 52 seconds south and longitude 153 degrees 23 minutes 3 seconds east, thence proceeding northmorth-east for a distance of 33.570 statute miles to a point situated in latitude 28 degrees 56 minutes 21 seconds south and longitude 153 degrees 32 minutes 30 seconds east, thence proceeding east-north-east for a distance of 4.957 statute proceeding to a point situated in latitude 28 degrees 55 minutes proceeding east-north-east for a distance of 4.957 statute miles to a point situated in latitude 28 degrees 55 minutes 5 seconds south and longitude 153 degrees 37 minutes 12 seconds east, thence proceeding south for a distance of 18.077 statute miles to a point situated in latitude 29 degrees 10 minutes 53 seconds south and longitude 153 degrees 37 minutes 45 seconds east, thence proceeding south-west for a distance of 18.077 statute miles to a point situated in latitude 29 degrees 22 minutes 29 seconds south and longitude 153 29 degrees 22 minutes 29 seconds south and longitude 153 degrees 25 minutes 42 seconds east, thence north-north-west for a distance of 4.957 statute miles to the point of commencement.
