COMMONWEALTH OF AUSTRALIA. ADMINISTRATIVE ARRANGEMENTS.

I SIR WILLIAM JOSEPH SLIM, the Governor-General in and over the Commonwealth of Australia, acting with the advice of the Federal Executive Council, do hereby—

(a) order that-

- (i) the War Service Homes Act 1918-1955, the War Service Homes Agreement Act 1932 and the War Service Homes (South Australia) Agreement Act 1934, in addition to the Acts at present administered by the Minister of State for National Development, shall be administered by the Minister of State for National Development; and
- (ii) the War Service Land Settlement Agreements Act
 1945, in addition to the Acts at present administered by the Minister of State for Primary
 Industry, shall be administered by the Minister
 of State for Primary Industry; and
 (iii) Division 2 of Part II. of the Re-establishment and
- (iii) Division 2 of Part II. of the Re-establishment and Employment Act 1945-1955, in addition to the portions of that Act and the other Acts at present administered by the Minister of State for Labour and National Service, shall be administered by the Minister of State for Labour and National Service.
- (b) approve of alterations to the Schedule to the Administrative Arrangements Order dated the twenty-first day of June, One thousand nine hundred and fifty-one, as set out in the Schedule to this Order.

Omit from the Second Column-

Financial Assistance to States for War Service Land Settlement

Omit from the Third Column—
War Service Land Settlement Agreements Act 1945.

The Department of Social Services.

Omit from the Second Column-

Provision of homes for Australian soldiers who served during the 1914-18 war and during any war in which His Majesty became engaged on or after 3rd September, 1939; also for female dependants of Australian soldiers and other classes of eligible persons as defined in the War Service Homes Act 1918-1949.

Omit from the Third Column-

War Service Homes Act 1918-1949.

War Service Homes Agreement Act 1932.

War Service Homes (South Australia) Agreement Act 1934.

The Attorney-General's Department.

Omit from the Third Column the reference to Division 2 of Part II. of the Re-establishment and Employment Act 1945.
