PROCLAMATION

Commonwealth of Australia to wit PAUL HASLUCK Governor-General. By His Excellency the Governor-General in and over the Commonwealth of Australia.

WHEREAS section 2 of the National Health Act 1972 reads as follows:—

- '2.—(1.) Sections 1, 2, 5 and 6, sections 31 to 36 (inclusive) and sections 38 and 39 of this Act shall come into operation on the day on which this Act receives the Royal Assent.
- (2.) The remaining provisions of this Act (other than subsection (1.) of section 3 and sections 14 and 30 of this Act) shall come into operation on a date to be fixed by Proclamation.
- (3.) Sub-section (1.) of section 3 and sections 14 and 30 of this Act shall come into operation on a date to be fixed by Proclamation, being a date not earlier than the date fixed under the last preceding sub-section.'

NOW THEREFORE I, Sir Paul Meernaa Caedwalla Hasluck, the Governor-General aforesaid, acting with the advice of the Federal Executive Council hereby—

- (a) fix the first day of January, One thousand nine hundred and seventy-three, as the date on which the provisions to which sub-section (2.) of section 2 of the National Health Act 1972 relates shall come into operation; and
- (b) fix the first day of March, One thousand nine hundred and seventy-three, as the date on which the provisions to which sub-section (3.) of section 2 of the National Health Act 1972 relates shall come into operation.
