## COMMONWEALTH OF AUSTRALIA ADMINISTRATIVE ARRANGEMENTS ORDERED BY HIS EXCELLENCY THE GOVERNOR-GENERAL

I, SIR ZELMAN COWEN, the Governor-General of the Commonwealth of Australia, acting with the advice of the Federal Executive Council, hereby approve the following changes to the administrative arrangements set out in the Administrative Arrangements Order made on 11 September 1979:

- (a) the enactments administered by the Minister of State for Business and Consumer Affairs no longer include the *Customs Act 1901*, Sections 219A to 219K (inclusive); and
- (b) the enactments administered by the Minister of State for Administrative Services include the *Customs Act 1901*, Sections 219A to 219K (inclusive).

## COMMONWEALTH OF AUSTRALIA

*Acts Interpretation Act 1901*

### ORDER UNDER SECTION 198A (3)

WHEREAS in Sections 219A to 219K (inclusive) of the *Customs Act 1901* there are references to the office of the Comptroller-General of Customs (being the office the holder of which is, by virtue of Section 25 of the *Public Service Act 1922*, the Permanent Head of the Department of Business and Consumer Affairs);

AND WHEREAS by virtue of administrative arrangements ordered by the Governor-General on 7 November 1979, there is a change in the matters dealt with by the Department of Business and Consumer Affairs but the name of that office is not changed:

NOW THEREFORE I, SIR ZELMAN COWEN, the Governor-General of the Commonwealth of Australia, acting with the advice of the Federal Executive Council, in pursuance of sub-section (3) of Section 198A of the *Acts Interpretation Act 1901*, by this Order, direct that such of Sections 219A to 219K (inclusive) of the *Customs Act 1901* as include a reference to the office of Comptroller-General of Customs shall have effect as if there were substituted for each such reference a reference to the office of the Secretary to the Department of Administrative Services.
