COMMONWEALTH OF AUSTRALIA ADMINISTRATIVE ARRANGEMENTS ORDERED BY HIS EXCELLENCY THE GOVERNOR-GENERAL

I, SIR ZELMAN COWEN, the Governor-General of the Commonwealth of Australia, acting with the advice of the Federal Executive Council—
