 - (b) the enactments administered by the Ministers of State administering the Department of Foreign Affairs and Trade include the Australian Trade Commission Act 1985, the Australian Trade Commission (Transitional Provisions and Consequential Amendments) Act 1985, the Export Expansion Grants Act 1978 and the Export Market Development Grants Act 1974; and
 - (c) the enactments administered by the Ministers of State administering the Department of Industry, Technology and Commerce include the Export Finance and Insurance Corporation (Transitional Provisions and Consequential Amendments) Act 1991 and the Export Finance and Insurance Corporation Act 1991.


