ADMINISTRATIVE ARRANGEMENTS ORDERED BY HIS EXCELLENCY THE GOVERNOR-GENERAL

I, WILLIAM GEORGE HAYDEN, Governor-General of the Commonwealth of Australia, acting with the advice of the Federal Executive Council, hereby approve the following changes to the administrative arrangements set out in the Administrative Arrangements Order made on 31 January 1992, to take effect on 1 July 1992:

- amend the second column of the Schedule to the Order under principal matters dealt with by the Department of Administrative Services by deleting the reference to Protective Services at Commonwealth establishments and diplomatic and consular premises in Australia';
- amend the second column of the Schedule to the Order under principal matters dealt with by the Attorney-General's Department by adding a reference to Protective Services at Commonwealth establishments and diplomatic and consular premises in Australia';
- amend the third column of the Schedule to the Order by deleting the reference to (c) the Australian Protective Service Act 1987 under the enactments administered by the Ministers of State administering the Department of Administrative Services;
- amend the third column of the Schedule to the Order by adding a reference to the (d) Australian Protective Service Act 1987 under the enactments administered by the Ministers of State administering the Attorney-General's Department.
